## PERMIT FEE SCHEDULE--EFFECTIVE APRIL 13, 1995

All annual permits expire on December 31.

### DRIVEWAYS:

Residential, Field Entrance, and Utility Structure:

New	\$ 20.00
Alteration to existing (Paving, widening, etc.)	\$ 10.00
Temporary (less than 6 months)	\$ 10.00

Commercial:

New (Parking area capacity of 10 vehicles or less)	\$ 50.00
New (Parking area capacity greater than 10 vehicles)	\$150.00
Alteration to existing driveways	\$ 25.00
Turn lanes added to existing driveways	\$ 50.00
Temporary (less than 6 months)	\$ 25.00

Applicant must: Secure written permission of adjacent State and Private property owners; Clear, grub, and remove stumps from edge of roadbed to right-of-way line; Topsoil, seed, and mulch all disturbed ground; Restore any disturbed road surface; Maintain traffic at all times; Comply with the Michigan Manual of Uniform Traffic Control Devices.

Access to publicly-owned sanitary sewer or water main--up to 36 square feet	\$ 50.00

Other than by publicly-owned sanitary sewer and water utilities, no pavement cuts allowed except in approved emergencies. Prior approval must be received before cutting. A \$20,000 bond must be provided, as well as the permit fee, before a permit is issued. Bond must be valid for one year after date permit is issued.

**TRANSPORT PERMITS:**

Overwidth/Overheight/Overlength:

Single trip	\$ 25.00
Annual Cab Permit	\$ 100.00

Utility vehicle transportation during weight restrictions \$ 100.00

Annual Cab Permits will only be issued for vehicles that do not exceed any of the following maximum dimensions: Width--12'6"; Height--13'6"; Length--75' or exceed the maximum allowable gross axle loading as listed on the extended transportation permit form. Other vehicles may be permitted on a single move basis.

Overweight:

Single trip	\$ 25.00

Permits for Overweight will only be issued for loads that cannot be separated or reduced. Annual Cab Permits will not be issued for vehicles which exceed the maximum allowable gross axle loading as listed on the extended transportation permit form and will not be issued for non-trailerred overweight equipment or machinery. Other vehicles/equipment/machinery/objects may be permitted on a single-move basis. ANNUAL OVERWEIGHT PERMITS ARE NOT VALID DURING SEASONAL WEIGHT RESTRICTIONS.

**TRANSPORT PERMITS: (continued)**

Mobile/Modular Homes:

Single Trip	\$ 25.00
Annual Cab Permit	\$ 100.00
Building/special load permit	\$ 100.00

Annual Cab Permits for the movement of mobile homes or prebuilt housing modules will only be issued to a mobile home transport company, a mobile home manufacturer, or a mobile home dealer, and only for the purpose of transporting mobile homes or modular housing units which do not exceed any of the following maximum dimensions: Width--14'; Height--14'; Length--80' (combined length--95'). Others may be permitted on a single move basis. Building moving permits will only be issued on a single move basis.

An inspection fee may be required on these permits. The amount of the fee will be determined by the anticipated cost of the inspection for the permit.
