

A regular meeting of the Alcona County Road Commission was held at the office of the Road Commission, Lincoln, MI, Wednesday, May 24, 2017, at 4:00 p.m. and was opened with the pledge of allegiance to the flag of the United States of America.

Jamieson expressed concern over the condition of the sealcoat done last year on N. Poor Farm Road. Managing Director reported he had inspected the road and while there is some break down attributable to the process and materials, the verdict is that the road was in such a state of deterioration the new sealcoat could not adhere properly. It was advised that the road should have been sealcoated several years ago and now really needs to be resurfaced.

Superintendent reported crews had been durapatching, prepping for sealcoating; completed some gravel projects; would start fog sealing soon; and had applied gravel and/or pit run in various areas.

Managing Director reported Carrick Trucking has proposed stockpiling natural gravel at their pit near Curtis Township for future road projects in the area; will be getting a quote for Team Elmers regarding millings from the former Wurtsmith base; depositions; holding on the plans for the garage awning and wash facility due to the death of James Russo; the new tractor is on site; picking up two new tandem trucks tomorrow; one grader is down; considering a gradall and/or an excavator for next year.

There being no further business, the meeting was adjourned at the call of the Chair at 5:46 p.m. until the next regular meeting on June 14, 2017, at 4:00 p.m.
