Alcona County Road Commission January 22, 2020 Board Meeting Minutes

A regular meeting of the Board of County Road Commissioners of Alcona County was called to order by Vice-chairman Harry Harvey at 3:59pm on Wednesday, January 22, 2020 at 301 North Lake Street, Lincoln, Michigan. Present: Vice-chairman Harry Harvey, Member Alfred Scully, Managing Director Jesse Campbell, Superintendent Michael Escareno, Account Clerk Renee LaVergne, and Administrative Assistant Lori Grush. Guests included Lisha Ramsdell with Huron Pines, Craig Johnston with the Alcona Board of Commissioners, and staff member Gary Anderson. Chairman Theodore Somers was excused absent.

Manager Campbell invited Ms. Ramsdell to speak to the board about some of our past accomplishments working with them and how we could improve our relationship with them to maintain some of the future projects. Ms. Ramsdell shared some of the collaborative projects since 2009. She stated that open communication is a priority for Huron Pines as well. There is a project that they have paused waiting to hear if the road commission is wanting to move forward with them. Manager Campbell asked her to explain how Huron Pines could help with invasive species control in our county. Ms. Ramsdell explained Huron Pines has been involved with invasive species management for 10 or 11 years and the current focus is primarily on phragmites and Japanese knotweed. Manager Campbell also addressed the need for Huron Pines to have a clear justification of why a project needs to be done. Commissioner Scully re-stated the lack of communication on the Trask Lake Road project. Manager Campbell acknowledged that Huron Pines is needing an answer on Kimberlin at Kurtz Creek and will look at continuing this project. Ms. Ramsdell was appreciative that the County was willing to have the dialogue with her and was hopeful that we would continue to work together.
