Resolution No. 2023-004

A Resolution concerning:

CODE OF CIVILITY

FOR the purpose of establishing a Code of Civility setting forth the manner in which members of the Board of County Road Commissioners should treat one another, staff, and members of the public, and establishing regulations for those attending public meetings in order to maintain proper order and decorum.

WHEREAS, civility is synonymous with courtesy, politeness, graciousness, tolerance, consideration, and respect; and

WHEREAS, civility requires that all members comport themselves in a manner that permits honest efforts at understanding the views and reasoning of others; and

WHEREAS, civility promotes a process that is fair and effective in both appearance and fact; and

WHEREAS, civility is attained through polite action and expression and it promotes a positive collegial atmosphere wherein the Board may operate effectively for the benefits of the citizens of Alcona County; and

WHEREAS, civility leads to effective communication and allows the finding of common ground; and

WHEREAS, the presence of the public at all open meetings of the Board of County Road Commissioners is an integral part of a transparent government; and

WHEREAS, public presence and participation must be adequately accommodated; and

WHEREAS, order and decorum must be maintained so that all members of the public may attend and observe the meeting without interference; and

WHEREAS, Section 3(1) of the Michigan Open Meetings Act, being MCL 15.263(1), provides that the right of a person to attend a meeting of a public body includes the right to tape-record, to videotape, to broadcast live on radio, and to telecast live on television the proceedings of a public body at a public meeting; and

WHEREAS, that section goes on to provide that the exercise of this right does not depend on the prior approval of the public body; however, a public body may establish reasonable rules and regulations in order to minimize the possibility of disrupting the meeting; and

WHEREAS, Section 3(6) of the Michigan Open Meetings Act, being MCL 15.263(6), provides that a person must not be excluded from a meeting otherwise open to the public except for a breach of the peace actually committed at the meeting.

Now therefore, pursuant to the above provisions, it is hereby

RESOLVED, that the members of the Board of County Road Commissioners of Alcona County shall in all their proceedings adhere to the "Code of Civility", a copy of which is attached hereto and made a part hereof.

BE IT FURTHER RESOLVED that a copy of this "Code of Civility" shall be posted at the entrance to all meeting rooms and on the Road Commission website and the presiding officer may read aloud all or any part of these regulations prior to the beginning of any meeting.

BE IT FURTHER RESOLVED that each member of the Board of County Road Commissioners shall sign a copy of this "Code of Civility" indicating their willingness and commitment to always act accordingly.

BE IT FURTHER RESOLVED that this Resolution shall take effect immediately.

MANAGING DIRECTOR'S REPORT

3:52p Dave Fialkowski joined the meeting

Manager Campbell shared that now the policies have been reviewed and updated, he'd like the board to think about scheduling a workshop to update our permits. He attended the MCRCSIP workshop and thought it was one of the best he has ever attended. A lot of legal updates including current court cases, road abandonments, and disposition of carcasses.

3:56p Larry King joined the meeting

In the next couple months, he'll be working on next years budget. The lowboy is now going to be here sooner than he had thought at the least meeting. The company will be honoring last years price and we should see it before the end of the year. He'd like to see about purchasing or leasing a loader next year. He'll also be researching graders. Both manufacturers are one year out. Other expenses for next year's consideration will include trucks, track skid steer, and the addition to the office. The board will need to decide if they wish to use the \$400,000 in the building fund. Campbell met with Beki Becky from Huron Engineering to do the drive around for Federal Aid projects for next year and the following two years. He will be scheduling with NEMCOG for the annual drive around with MDOT. We were denied on all three grants that Campbell had applied for. The US23 project is currently set to open to traffic on August 4th and are expecting a August 15th project completion.

Commissioner Harvey asked about the dump site. Campbell shared that he had located all of the vent pipes and it looks like seven will have to be replaced. He will be asking DEQ for a variance regarding the removal of the autumn olive. They are trees, not bushes.

Commissioner Scully inquired about the State Park sign on US 23. Campbell stated they have measured it and we provided MDOT contact information to the property owner regarding his ditch on US23.

PUB LIC COMMENT

Chair Somers asked the two guests that arrived to introduce themselves. Dave Fialkowski and Larry King were present.

Larry King from East Tait Road addressed the board. He lives at the very end off Cruzen. Thanked us for the quick response in the spring. Stated there is about a 9 inch difference between the metal and the road where the culvert was repaired. Rocks have come up out of the ground because all that is on the road is dirt. It needs gravel put down. There are trenches 6 inches deep. Can something be done before winter? He stated he has attended both Gustin and Mikado Township meetings. Discussion ensued.

County Liaison Craig Johnston arrived at 4:10pm

Manager Campbell is going to see what the Road Commission might be able to do that wouldn't require a township agreement. If we are able to do anything, it wouldn't be until late fall. Campbell could not and would not promise anything.

Dave Fialkowski was looking for an update from the board after his visit several weeks ago about his property on West Lake Street and the Road Commission continuing to widen the road onto his property. Also referenced the increased speed of vehicles and the pine tree his neighbor planted that drivers veer around to avoid. Manager Campbell stated the due to legalities, we cannot move a road. The township would need to make that request in writing to have it resurveyed. Campbell encouraged him to reach out to township supervisor and Campbell would do the same.

Mr. Johnston didn't really have any updates. He did share that the county is looking for a new equalization director. He also shared that they are looking to see if any of the ARPA funds could be used for the landfill.

Mr. Fialkowski addressed the board again about his road and his frustration with communications from past boards and management.
