#### MANAGING DIRECTOR'S REPORT

Manager Campbell shared that Harrisville Township last week approved a \$2,000 not to exceed share cost to the Dean Road culvert . The 2024 project proposals, Hubbard Lake Road from Ritchie Road to the township line and Bamfield Road from Demott to AuSable are entered and approved by MDOT and should be ready for an April letting. Structure #29, the Cruzen Road Bridge, has been selected as a candidate for reconstruct through the National Bridge Association. We should hear back within the next 60 days on it. The 3/4ton pickup has been ordered from Alcona Motors. Huron Pines did release all the plans for the 4 bridges in the Black River Water Shed. They will meet again next week. Currently they have it that all funds and projects be completed in 2024 and nothing has been ordered yet so they are looking to see what kind of extensions can be gotten. The two culverts will then be rated as bridges so it will increase our bridge infrastructure.

#### PUBLIC COMMENT

Superintendent Escareno wanted to clarify that he felt the crew did a fine job with two snow events back to back and all the trees.

Chris Scully addressed the board about a private individual off of Taylor and Quick Road plowing snow across the travel portion of Taylor road. Campbell will look at it.
