## Alcona County Road Commission August 13, 2025, Board Meeting Minutes

A regular meeting of the Board of County Road Commissioners of Alcona County was called to order by Chairman Ted Somers at 4:00pm on Wednesday, August 13, 2025 at 301 North Lake Street, Lincoln, Michigan with the Pledge of Allegiance. Present: Chairman Ted Somers, Vice Chairman Harry Harvey, Managing Director Jesse Campbell, Superintendent Mike Escareno, Clerk Renee LaVergne and Administrative Assistant Lori Grush. Three guests were present.

### PUBLIC COMMENT

Susan Calder from Harrisville Township addressed the board regarding the Springport Road access. Spoke of the narrowing of the road, vegetation growth, invasive species, difficult parking, and obstructed signage.

Charman Somers thanked her and continued with agenda.

### PUBLIC COMMENT

Chairman Somers asked Ms. Calder to continue her concern. She showed four pictures to the board members she took at the Springport Road access.

Manager Campbell was aware of the situation and shared that the road commission only maintains up to the guardrail. The rest is a responsibility of the township. Manager Campbell stated we do have it on the list for brushing up to the guardrail but we have no time frame available. USDA would determine if and what chemical brush control is possible so close to the lake. Chair Somers reiterated that it is on our list for brushing.

Ms. Calder left the meeting.

Craig Johnston, Alcona County Commissioner liaison, updated the board on the new Treasurer, new Prosecutor and new administrative person in the Building Department.

### SUPERINTENDENTS REPORT

Superintendent Escareno shared that the mowing in the county has wrapped up and we will probably do a second run on the state routes if allowed and possibly F41 after the holiday. The brush tractor has been in Mikado Township working on some problem areas and some ditching has been done in Mikado Township and Caledonia Township. Crews started on fog seals and wrapped up those on the seal coats that we had already completed and we had 22A delivered for Bissonette Road. Today, we did the single seal on Bissonette and Pine Street in Curtis Township and they'll go back to Bisonette tomorrow to finish it up. Then we'll move on to Aspen Alley. Commissioner Harvey asked if the asphalt projects were completed. Manager Campbell added that Mt. Maria still needs to be overlayed. Bolen Asphalt still has plans for that this year.

The companies charge a 5% fee. As a force account we will not receive more than 75% of our total loss. We have already been assigned an agent and meet with them next Wednesday.

## MANAGING DIRECTOR'S REPORT

Manager Campbell shared that the new insurance rates for 2026 should be available the last week of August and then the hard caps the beginning of September. We'll have to evaluate then if a change is needed. He had the pre-con meeting for the LaVergne Road Bridge this morning. John Henry was the low bidder and will be setting the temporary bridge and removing the old structure. He will start the end of September. His schedule should be locked in next Monday. The Road Commission will be assembling the superstructure. We have to be out of the waterline by October 1st. We can still be assembling the bridge after that. The motor grader has been ordered and 2 pick-up trucks have been ordered. Kenny is still looking into purchasing our lease out or a different used grader. Manager Campbell does not have any information on the security upgrades for the office yet. A few of the investments expired today, so the \$1.2M is out and available. Campbell stated he will review after October 1 and see about reinvesting for next year based on our cash flow and projects. Campbell shared regarding the Federal Aid Projects that Hubbard Lake Road is completed and so is Aspen Alley and the paying on F30 is completed. Sheila at the county has been amazing. He will have information at the next meeting regarding the Monarch Butterfly Endangerment. He has submitted the form to pay to have our milkweed monitored each year.

## PUBLIC COMMENT

Mr. Johnston asked if Harrisville Township could hire someone to clean up the access. Manager Campbell said they could. There has been disagreements in the past on who owns that property. It would still require an EGLE involvement which will require permission from the land owner. Johnston also added that the township was very pleased with the work done on Poor Farm Road.
