Asset Management Plan Resolution

Manager Campbell explained the requirement by the state.

RESOLUTION 2025-005 2024 Asset Management Plan

WHEREAS, the Alcona County Road Commission is required by law to certify its compliance with Public Act (PA) 325 of 2018; and

WHEREAS, PA 325 requires the Alcona County Road Commission, with more than 100 certified miles, to submit an asset management plan to the Transportation Asset Management Council (TAMC) on a three-year cycle

WHEREAS, the Alcona County Road Commission has developed a Transportation Asset Management Plan (TAMP) for its road, bridge, culvert, and traffic signal assets per PA 325; and

WHEREAS, the Alcona County Road Commission has met the minimum requirements as outlined in PA 325 and agency-defined goals and objectives,

NOW, THEREFORE, BE IT RESOLVED that the Alcona County Board of Road Commissioners approve and adopt the 2024 Transportation Asset Management Plan.

BE IT FURTHER RESOLVED that the Chairman of the Board and the Chief Administrative Officer are hereby authorized to sign the certification form.

MANAGING DIRECTOR'S REPORT

Manager Campbell let the board know that the Lavergne Road bridge has been uploaded but they sent it back. We now need engineer to do load rating for the bridge within 60 days. MDOT is taking over the bridge inspections, so Great Lakes has been pulled. MDOT awards the bid January 1 for inspections, so Campbell requested extension. He signed off yesterday for the FEMA funds. Now just waiting on the state police to sign off for reimbursement of costs. He has had a couple requests to extend material bid contract into next year. He will have that at the next meeting. At the RTF meeting, it was announced they are going to allow the federal buyout again.

Commissioner Harvey asked about Hubert Road bridge. Discussion ensued.

Mrs. Savoie from Curtis Township thanked the road commission from Curtis Township for the work done. She also requested a stop sign at Brodie and Aldridge Road. Not sure if it was knocked down if it was never there.
