**WHEREAS**, *The Alcona County Board of Road Commissioners fully supports the efforts to secure State and Federal Local Road Funds for resurfacing of Aspen Alley Road from F4001 to M-65 in Sections 26,27,34, and 35, T27N, R5E Mitchell Township*

*and Sections 3,4,9,16,21, and 28, T26N, R5E Mitchell Township, Alcona County, Michigan, and*

**WHEREAS**, *the project includes hot mix asphalt overlay, aggregate shoulders, permanent signing, and pavement markings: and all together with necessary related work, and*

**WHEREAS**, *the Alcona County Road Commissioners authorize Board Chair Ted Somers and Vice-Chair Harry Harvey to sign the document on behalf of the Alcona County Road Commission.*
